Thank you for your interest in a leadership role within the Maverick Party. The purpose of this questionnaire is to explore your background more comprehensively. As a candidate for MP or Party Leader you will undergo intense social media scrutiny. Our opponents will dig even deeper in their attempts to discredit both you and the party. We need to be prepared.

Fill in your information and save it as a PDF. The first section is more of a resume. Who are you? Where have you lived? Your education and past jobs. Some background on your family. What have you done in the past that would make you an effective member of parliament? This is a position that requires considerable communication and people skills.

The next section will deal with obvious pitfalls. Have you had any legal issues both in your personal and business life? There will be a criminal record check and Vulnerable Sector screening. Both are required in many jobs including even being a voluntary scout leader.

Have you had financial challenges that might raise questions about your fiscal skills? MPs routinely vote on projects worth millions and billions of taxpayer dollars.

Perhaps the biggest and most immediate danger will be your social media. Everything you have posted or communicated is basically open season. Even if you think you have scrubbed your Facebook or Instagram you never know who has taken screenshots over the years. We need to know what was posted and when. Having something surprising come out during a campaign could be a disaster for your election and the election of others. Letting us know now is much better than being blindsided later and having to withdraw from the campaign.

Its important that you answer the questions carefully and honestly. A few minor blemishes or setbacks is normal and even expected. But we need to know now in order to create an election strategy that allows the party to win as many seats as possible with as little distraction as possible.

NOTE: With an early campaign expected in October all campaign material, strategy and management must be done centrally. As a candidate all material must be from Maverick HQ or approved by Maverick HQ. We are offering voters a choice between doing the same old same old of electing Conservative MPs OR send a clear message to Ottawa that the West has had enough. The campaign focus will be on the party not the candidate.

In accordance with the Maverick Rules and Procedures, any person wishing to be a leadership nomination contestant is required to complete and sign the Maverick Leadership Nomination Questionnaire. Email the completed form to <maverickcandidate@protonmail.com>

For **Party Leader** you will also need to submit a completed nomination list bearing 1000 signatures of registered party members. At least 150 of these member signatories must reside in each of the 4 western provinces. There is a payment required of \$5,000 to Maverick Party plus another payment of \$1,000 as a refundable good conduct bond. Both are required prior to the competition deadline to be considered a candidate.

To be a candidate for **Member of Parliament** you must submit a completed nomination list bearing 250 signatures of registered party members able to vote in riding you are running in. There is a \$1,000 payment required to Maverick Party plus another \$1,000 as a refundable good conduct bond. Both are required prior to the competition deadline to be considered a candidate.

These payments are not donations and do not count towards any spending limit imposed by Elections Canada on leadership nomination contestants. Leadership nomination contestants who are deemed by the Executive Director to have abided by the rules and procedures will have their good conduct bond repaid within three months of the nomination contest results being certified.

The Nomination Contestant Questionnaire is designed to:

- 1) Assist the Nominations Committee (NC) in the evaluation of the suitability of the potential leadership nomination contestant;
- 2) Assist in the preparation for the interview with the contestant;
- 3) Provide the Maverick Party with information for election readiness and election strategy.

Applicants are required to inform the appropriate Nominations Committee of any new information or circumstances that may change the responses to any of the questions in the Nomination Contestant Questionnaire.

If the contestant has been found to have provided any false or misleading answers to any questions in the Nomination Contestant Questionnaire, they may be disqualified from the nomination contest.

In this video, a nomination contestant should introduce him/herself, provide the reasons why he/she is interested in running as a candidate for **Maverick**, and why he/she thinks that he/she would make an effective candidate in the riding where they are seeking candidacy.
